Deutsche Eigenheim Union AG names as authorized representative of voting rights Ms. Mareike Kuliberda, employee of Link Market Services GmbH, Munich. The proxies are authorized to vote only to the extent that you have issued an explicit instruction on the individual resolution proposals of the administration on the agenda items. The proxies are required to vote according to your instructions via the proposed resolutions of the administration published in the agenda. The following options are available to you for appointing a proxy with instructions to exercise your voting right:

Letter or e-mail of power of attorney and instructions to the proxies of the Company

To do this, please use the overleaf form entitled "GRANTING POWER OF ATTORNEY AND INSTRUCTIONS TO VOTING REPRESENTATIVES". In doing so, authorize the abovementioned proxies of Deutsche Eigenheim Union AG and instruct them as to how your right to vote in relation to the proposed resolutions of the administration should be exercised.

Important instructions:

Please note that the instructions to exercise your voting rights are only valid if you have issued the ticket (s) for your shares in your name and have filled in and signed this authorization and instruction form together with your ticket (n) or giving your ticket number (s) to the proxies by Tuesday, July 05, 2022. After this time we ask you to use only the following e-mail address: inhaberaktien@linkmarketservices.com. If the proxy holders receive authorization and instructions by several means of transmission (post, e-mail), the formally valid power of attorney issued with the relevant instructions will be deemed binding. If the powers of attorney have not been formally granted, the proxies will not represent the votes in the Annual General Meeting. If instructions are not filled out correctly or are not clearly given, depending on the voting procedure, the proxies will abstain from voting on the relevant agenda items or will not vote. The proxies are bound by instructions and may not exercise their voting rights in the case of votes not known prior to the Annual General Meeting (eg in the case of procedural motions). Depending on the voting procedure, the proxies will abstain or not vote in these cases. The same applies to the vote on a countermotion, in the case of a nomination deviating from the proposal of the administration, and in the case of a resolution deviating from the management proposal published in the agenda. The commissioning of the voting representatives of the company for the declaration of contradiction as well as for the application and questioning is excluded. In the event of personal participation or participation by an authorized third party at the Annual General Meeting, the power of attorney granted in the run-up to the Annual General Meeting and the instructions to the proxies of the Company expire.
